- 3. Max Axelsen presented the physical and financial status of the 2009 San Antonio, TX Reunion. The report revealed a well organized program, which Max reported to be under budget. Approximately 85 will be in attendance.
- 4. Max Axelsen reported on the death of our first President and one of the founders of the Association **Robert Butler**. Max provided a floral tribute in the name of Ken'sMen. Jim Dieffenderfer, who attended, told of the large gathering for Bob's "Final Roll Call"
- 5. Ed Gammill, Group Recruitment, reported issuing 7 invitations and gaining 3 new Associate Members.

NEW BUSINESS

- 1. President Lawson reported that due to illness, Donald Marsaglia must resign the Vice President position. A nomination and election must be conducted in the General Group Meeting.
- 2. The Secretary reminded Headquarters, 63rd, 64th, 65th and 403rd Squadrons of Board members whose term expires December 2009. They were informed to elect a person to fill that vacancy at their Squadron Meetings.
- 3. Susan Lanson, Associate Member and daughter of Leonard Clark, 403rd Squadron, Pilot and Michael La Vean gave brief review of the George Mason University's archival activities. They also informed the Board, that a George Mason archivist would present a slide show with discussion of the University's capabilities during the General Meeting.
- 4. Nancy Solomon, the sponsor of the 2010 Reunion, reported her current status. The Reunion is scheduled to be in September 8 through 12 at CORONOADO SPRINGS Convention Center, Lake Buena Vista, Florida. A motion was made, second and passed to provide \$6000 start-up funds for this activity.
- 5. President Lawson directed the formation of a committee composed of Jim Dieffenderfer, Arvid Houglum, Roger Kettleson, Max Axelsen and Eldon Lawson. The charter of this committee: To study the shut down of the 43rd Bomb Group Association, to investigate and propose a physical and financial program to be implemented upon the decision of the General Group Meeting that the Association should be closed.
- 6. President Lawson read the following e-mail from Jim Cherkauer, dated September 15, 2009.

REPORT ON STATUS OF 43RD HISTORY BOOK

It is difficult with any precision to state where our book stands at present. A bit over two months ago Larry had serious surgery for cancer in his neck close to his head. Fortunately, the doctors found that they did not have to severe any nerves and were able to remove the tumor without invasion of the brain, which was once feared. Larry has been undergoing radiation and chemotherapy for about two months.

Larry claims that our book is being worked, at this time, with one writer assigned and another helping as he can. I did receive Appendix III from the graduate student working this section. It is a listing of "all" of our aircraft including dates of manufacture, serial numbers, when the aircraft (A/C) first joined the Group, dates of loss or retirement, etc. When possible there is a list of pilots who flew each A/C as well as missions, in which, the A/C participated. I shared this appendix with every member of the association on my e-mail address list. I asked each to make any corrections, additions or other information about the A/C.

Meanwhile Larry had promised ,on two occasions, to send me the 1945 partial draft of our history to read. I will not be doing proofreading, but I would be free to make any comments that I wish to make. To date I have received nothing. He did share the colored reproductions of several of our airplanes, but asked that they not be shared with others as they are copyrighted and will be in our history book. He does not want these circulated before publication.

I receive the usual promises that our book is nearly finished and should go to press this year. We have heard this for nearly 20 years, so I offer no date for its publication. Larry has hired a good staff and these people are working on the book. He has spent a fortune paying these people and having colored reproductions of 43rd aircraft using the most up-to-date methods. That is all well and good but I see no reason to think our

After receiving an E-mail from Joseph Bass, I asked Joseph for additional information about his father. This is his reply: "I don't know the exact dates that my dad was drafted. He and his classmates were seniors in high school. He received his GED after he returned. If he was held back like he said, then he would have graduated in 1945. So he must have had time to be trained in gunnery school before he was shipped out to the Philippines. He remembered when the Japanese brass stopped at his forward airfield on an island to switch to a C-47 and continue to the meeting with MacArthur for the surrender.

He was never one to embellish his stories, but he told me a few years ago that their last mission was for weather reconnaissance over Hiroshima. Probably one of many that were flying at that time. He had just turned twenty years old, when he learned that an "atom bomb" was dropped on Japan. He told me no one was really sure what that was.

His squadron (63rd) as you know, flew black B-24 Liberators on night missions. They were called "SEAHAWKS." He said it was terrifying being shot at while being lit up with spotlights. He started as a Ball Turret Gunner, but was moved to the Nose Turret position. He also said he saved his bus money and hitchhiked back to Oklahoma because it was easy to get a ride if you were wearing the uniform.

You might be surprised to learn that my dad was a full-blood Sac and Fox Indian. He was buried with full Military Honors in a traditional ceremony only a couple of miles from where he was born. We will always be proud of our father's service to this county and of all veterans service. I thank all of you."



For 64 years I've searched for an Eldon Lawson of Missouri—no, not me, another Eldon Lawson, and now I've finally located hm. Here's how I learned of him. In September 1945 at le Shima, the mail Sergeant of the 65th Squadron called out too me after I picked up my mail. He said, "Lieutenant, I'm sure glad that you always use your middle initial E, because we have another Eldon Lawson in this outfit." As I expressed surprise, maybe doubt, the Sergeant produced a letter addressed to Sgt. Eldon D. Lawson postmarked, Kirksville, MO. I began to inquire of Sgt. Lawson, but soon learned he had "shipped out." I was surprised that I had not heard of him before.

Hi Ed, Thanks for your prompt reply, and here is requested info.: Arndt, Rudolph P,, lst Lt., Air Corps (ret.) and joined the 43rd Assn some 10 years ago. I was at Owi from Sept. l, 1944 to Jan. 10, 1945, atttached to the 63rd Bomb Sq., and a member of the Ferret Detachment (Sec. 22, GHQ). There I flew on 12 combat (lone reconaissance) missions, as the Radar Observer, on Atom Smasher and Duchess of Paducah B-24's, both being the first specially-equipped aircraft for detecting and locating enemy radar installations Have looked up original info. and these two were B-24D's. Details re. my flight to Leyte on Jan. 10, 1945 with your group's nightly shuttle, are in the Newsletter 85th Edition, Jan 2003.. I was sent back to the USA after 2 weeks at Tacloban, Leyte. Of course, little of this possibly bears repetition.

One or two other entries in the Newsletter related to me in the past too. It seems that no others of our Ferret Detachment ever managed to find and join the 43rd Bomb Group Assn, and my efforts at locating several of them have failed (via internet, phone books). At my age, 91 years, possibly few if any remain, unfortunately. I know you are expert at "finding" people from the past but do not wish to burden you with any such.

Extra info. that I rec'd. from **Bob George** re. Owi Island is that the level of the already existing coral surface initially varied only l foot in over 7000 ft. of desired runway length!!! What a near-miracle for the creation oif our airfield there The engineers wondered if all of our military equipment would "sink" the island appreciably!!. He wore out 2 pair of jungle boots in surveying the whole perimeter of the island, and contracted scrub typhus a little later. Fortuntely he recovered, and he states that the overall recovery rate was only 17% due of course of lack of any knowledge about treatment, other than rest, proper diet, etc.

B. George is irked that Owi Island has received so little attention! I found the experience there was memorable, and have worn out family members which retelling the stories. "We" lived right din the 63rd Sq. tent area, and your crews took turns flying the two Ferret aircraft on the missions. Perhaps that is enough of the old experiences, and I will quit right here with the letter. Thanks again for answering and planning on including the map in O(ctober! Best regards, Rudy





A day of service will get you a day of Disney-style fun

NO DOWN SIDE: Analysts say initiative is a winner for the company

NEW YORK — Disney is offering a free day's admission to a million guests who complete a day of volunteer work next year.

The "Give a Day, Get a Disney Day" program will provide certified volunteers with a oneday ticket to any park at Disneyland in Anaheim, Calif., or Walt Disney World near Orlando in 2010.

Disney is partnering with HandsOn Network, a clearinghouse for volunteer opportunities, to connect people with projects and to certify that the work was done.

"We are trying to inspire I million people to volunteer in their communities and we're inspiring them to do that by giving them a free day at a Disney park," Jay Rasulo, chairman of Walt Disney Parks and Resorts, said in a phone interview

with The Associated Press.

Rasulo, called the promotion "very timely," citing the increased needs of nonprofits in the weak economy, as well as President Obama's national volunteering initiative.

"The spirit of our country is very much behind that, whether it's the first family or whether it's the average family," Rasulo said.

Duncan Dickson, who teaches theme park management at the University of Central Florida's Rosen School of Hospitali-

ty Management in Orlando, said the volunteer initiative is "a smart marketing move."

Dickson said Disney will get good buzz for encouraging volunteerism, plus free publicity from the nonprofits that benefit. And even when theme parks let people in for free, they make their money back in other ways, Dickson said.

"You make a lot of money in popcorn and T-shirts and other things," Dickson said.

Some guests who come in for free would have bought tickets anyway, but the offer will also bring in visitors who would not otherwise have made the trip, Dickson added, and they will bring paying guests with them.

"Anything that pushes the turnstiles is good for business," Dickson said.

HandsOn Network has 70,000 affiliated agencies, from Habitat for Humanity to local food banks, churches, health care centers, and educational programs.

Once their service is verified by HandsOn, volunteers print out an online certificate that can be redeemed at a Disney park.

The free admission offer is part of a larger trend in the tourism industry, using everything from free hotel nights to two-for-one discounts to attract visitors in the weak economy. Disneyland this year offered two free nights with the purchase of three nights at a Disney resort, and all the U.S. Disney parks have allowed guests in free on their birthdays this year.

Rasulo said that 3.5 million people registered for the birthday promotion and about 30 percent of them have taken advantage of it so far.

Disney kicked off the volunteer promotion Tuesday by sending 1,000 volunteers, including employees from Disney and Southwest Airlines, to work on projects around the country, from a Habitat for Humanity site in Los Angeles to the Bethune School of Excellence in Chicago. Examples of volunteer opportunities listed on HandsOn's Web site range from drivers and bingo callers to a book drive organizer at a senior center in Scranton, Pa., to a docent at the Oregon Maritime Museum in Portland.

→ Volunteers who have multiday tickets or annual passes can get a special Fast-pass for up to six people in lieu of the voucher. Fast-passes allow visitors to bypass lines at the parks' most popular attractions.

Financial analysts who follow Disney said there was no downside to the pro-

"It's a nice thing, it's a very socially responsible thing," said Michael Nathanson of Sanford C. Bernstein & Co. in New York.

"I don't look at this as a tremendous cost for Disney," said Alan Gould of Natixis Bleichroeder Inc. in New York.

"It could stimulate some incremental demand as well. It certainly is good publicity and economically it could make sense."
