Dear Members,

At last the 2012 Dayton Reunion is a done deal. It is scheduled for October 24 thru 28. We contracted with the Armed Forces Reunion, Inc. (AFRI), Norfolk ,VA to assist in the planning. We will be at the Holiday Inn, Fairborn, OH. Only 5 miles from the Air Force Museum and 21 miles from the Dayton International Airport. Please read the attached instructions carefully.

Registration for the reunion is being handled by AFRI, all funds should be sent to the address shown on the attached Registration Form. There is a required registration fee of \$10 per person which is not refundable. All meals and events are at your discretion and the charges listed are for each person participating. Printed tickets will be issued and they will be collected at each event. Register for the reunion with AFRI. Make your room reservations with the HOTEL!

The hotel rate is \$95 plus 12 ½% tax, and will be extended 3 days before and after the reunion schedule. The cutoff date for a guaranteed room and rate is October 3. If your plans change, you may cancel the hotel reservation until 6:00 PM on the day before your scheduled arrival. Please wear your ID badge or at least have it with you at all times. In the past we have had some people, we entertained and fed, that had no connection to our group. Thanks so much for the work preformed by **Michael La Vean and Susan Lanson**. Without them, I could not have put it together.

What ever the cost of printing and mailing I would like to pay it if you'll let me know how much it is. Note from the Board; The wives of members, who have passed away ,do not have to pay dues. Jean, we just want to know if you still wish to receive the newsletter. COMP members do not need to do anything except indicate the wish to continue receiving the newsletter!

"I have found a couple of photos taken while Art was **Intelligence Officer** in the Japanese theater of operations and will send them to you, along with anything else I may discover. Am trying to get papers and miscellaneous items to where they are useful.

"In our files there are newsletters from July 1997, of which only a couple, would I like to keep. Do you know of any one who would like to have them? Your already have Art's book of cartoons. I also have his letters to me which have the original in them. Art felt badly that he briefed crews, sent them out and sometimes, of course, they did not return. So he inveigled one of the pilots to let him go on a mission. I think he wished to get the feel of such operations. He did not tell me about this until a long time after returning home.

"He was on Ie Shima or Iwo Jima when the war ended and most of the men in his group were sent home. However, he and some 16 others remained to "clean up." The 17 men had steak, ice cream and other wonderful food items for thousands of men, that we civilians had not see for quite awhile. This little group kept trying to get deactivated, but no word came; so in desperation they finally flew a war-scarred plane to Tokyo—it almost didn't get off the ground—but they made it. When they arrived at headquarters, they told that they had been declared AWOL and would not be given their merited promotions, etc. The matter was finally straightened out. They received promotions and were sent home several months after they should have been!

"In the meantime, I had been receiving calls from some of his buddies and very good friends assuring me that he should be home shortly—'shortly was not to be! However, eventually he did get home, thanks be to GOD.

"If you wish to use some of the stories, you may. If I find any more in some of his writings, I'll let you know. Best wishes, to all, for your health, happiness and prosperity in all the things that matter."



My dad, Albert Feldbin, bombardier on the same crew, had copies of the originals. The first two are marked and dated on the back "8/9/45 Kumamoto mission"; the last one is marked "Nagasaki 8/9/45, 11:45AM".

According to an interview my father had with the NYS Veteran's Oral History Project a few months before he died: They were returning from a strike on Kumamoto and Oita and diverted around some weather which is how the managed to be in the vicinity of Nagasaki. Notes from Dad's mission log gave the column height as approximately 40,000 feet. Aircraft tail number 543.

# Super Strength of Body and Mind and a Strong B-24

Lt. Ervin Miskin, pilot turns a near disaster into a saving day.

He didn't get the Air Medal, not even a letter of commendation for his fight to save his B-24 and the lives of his crew.

It was January 1, 1944 when Lt. Miskin and his crew of the 403rd Bomb Squadron, 43rd Bomb Group, 5th Air Force departed on their 8th combat mission from Dobodura Air Base. New Guinea, A 10 hour reconnaissance around the Bismark Sea and Rebaul, over New Britain, Kavieng and New Ireland, primarily looking for shipping or other enemy activities. While flying in the New Britain area toward Rebaul, we sighted a Japanese "Sugar Charlie" (a small class freighter) off Cape Haskins Japanese fighter strip. We started our bombing run from 5,000 feet. From my tail turret position, I could see the flashes and tracers of very heavy accurate ack-ack. Five seconds before bombs away, we took two direct hits with one 20 mm shell in #1 engine, knocking out its hydraulic system and causing a trail of flame past the tail turret. Another hit the right horizontal stabilizer, tearing it to shreds spreading flack through the tail knocking out my gun turret hydraulic system, both direct hits and near hits spreading flack throughout the plane.

The engine was on fire for 7 minutes, we started plunging toward the sea and the order was given to prepare for a crash water landing. The bombs were salvo'd, ammo boxes, helmets and waist guns were thrown out. But the pilot finally pulled out of the dive 25 feet above the water, but so low that we siphoned up sea spray through the bomb bay doors and the belly ball turret. We skimmed along New Britain coastline not being able to gain enough altitude to fly over it. We could see the enemy scurrying from their san pans and small coastal vessels on to the beaches and into the jungle at the sound of our approaching plane.

On more than one occasion, there was talk of ditching, as the effort to maintain a course and altitude with the wind milling prop and damaged elevator contsrol took super human strength of body and mind by pilot and co-pilot.

About an hour into our return flight and having radioed our position, two P-40's found and escorted us until we were clear of the enemy area. After 2-1/2 hours, the pilot positioned the crew in the crash landing mode again as we were going to land on a short advanced fighter strip at Finschhafen.

With the right horizontal stabilizer damaged, the #1 engine wind milling, possible left landing gear tire flat and as it turned out, approximately 480 flack holes in the plane, he made a near perfect landing.

The B-24 was "Miss Mc Cook" #070 on what we thought would be her last flight. She was repaired and lived to fly again. We returned to our home base the following day via ATC. Moral of this story is: "Sighted enemy ship - same almost sank us"!

On 28 March 1944, I/Lt. Ervin N. Miskin, pilot, T/Sgt. Royal N Greiner, our engineer; T/Sgt. Frank D. Brumm, our radio man, died when the B-24 they were ferrying to Garbutt Field, Australia for major repairs crashed into a mountain top during a hurricane type rain storm.

Because of Lt. Miskin's faith in God, his family, his crew, the United States of America and himself as a pilot, the following crew members are a living memorial to him, even 60 years after this violent mission: Hayden Clark, Ed Driscoll, Orley Caudill and Wade Kehr, scribe.


